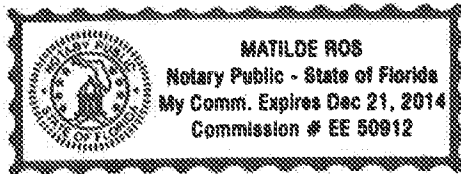

I, Brian A. Sullivan, a resident of the State of Connecticut, hereby declare as follows:

1. I have personal knowledge of the matters set forth herein and, if called upon as a witness, would and could competently testify thereto.
2. I am the Chief Financial Officer of DJP Concepts IP Sub, LLC, which is the current owner of the above-referenced trademark registrations (the "Marks").
3. DJP Concepts IP Sub, LLC was formed on February 7, 2011.
4. DJP Concepts IP Sub, LLC is and always has been a Delaware limited liability company.
5. On February 14, 2011, the original registrant of the above-identified trademarks, Donald J. Pliner Concepts, Inc., a Florida corporation, assigned the entire interest and goodwill in the Marks to DJP Concepts IP Sub, LLC.

6. In connection with this assignment, there was a typographical error in the recorded assignment document at Reel/Frame 004481/0717 identifying DJP Concepts IP Sub, LLC as a Florida limited liability company rather than a Delaware limited liability company.

7. DJP Concepts IP Sub, LLC has never been a Florida limited liability company.

8. I have personally initialed and dated the corrected assignment document being filed contemporaneously with this declaration to accurately reflect that DJP Concepts IP Sub, LLC is a Delaware limited liability company.
