Pursuant to Section 17-6702(c) of the General Corporation Code of the State of Kansas (the "KGCC"), Sunrise Growers, Inc., a Delaware corporation ("Sunrise"), hereby certifies the following information relating to the merger of Packers Food Products, Inc., a Kansas corporation, with and into Sunrise (the "Merger"):

**FIRST:** The name and states of incorporation of each of the constituent corporations (the "Constituent Corporations") are:

**SECOND:** An Agreement and Plan of Merger has been approved, adopted, certified, executed and acknowledged by each of the Constituent Corporations in accordance with Section 17-6702(c) of the KGCC.

**THIRD:** Sunrise shall be the surviving corporation of the Merger (the "Surviving Corporation") and the name of the Surviving Corporation following the Merger shall be "Sunrise Growers, Inc."

**FOURTH:** At the effective time of the merger, Sunrise's Certificate of Incorporation, as amended, shall be the certificate of incorporation of the Surviving Corporation.

**FIFTH:** An executed copy of the Agreement and Plan of Merger is on file at the executive offices of the Surviving Corporation, located at 701 W. Kimberly Ave., Placentia, California 92870.

**SIXTH:** A copy of the Agreement and Plan of Merger will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of the Constituent Corporations.

**SEVENTH:** The Surviving Corporation agrees that it may be served with process in the state of Kansas in any proceeding for enforcement of any obligation of any Constituent Corporation of the State of Kansas, as well as for enforcement of any obligation of the Surviving Corporation arising from the Merger, including any suit or other proceeding to enforce the right of any stockholder as determined in appraisal proceedings pursuant to the provisions of Section 17-6712 of the KGCC, amendments thereto, and the Surviving Corporation does irrevocably appoint the Secretary of State of the State of Kansas as its agent to accept service of process in any such suit or other proceedings and designates 701 W. Kimberly Ave., Placentia, California 92870 as its address for receiving copies of such service.


