
Declaration

I, Richard K. DeScherer, hereby declare:

1. Barclays Risk Analytics and Index Solutions Limited ("BRAIS"), now known as Bloomberg Index Services Limited ("BISL"), is the true and correct owner of the trademarks identified in the assignments recorded at reel/frame number 5927/0202, and listed on the attached schedule (the "Trademarks").
2. On August 24, 2016, Bloomberg L.P. acquired BRAIS.
3. On November 16, 2016, Bloomberg L.P.'s subsidiary, Bloomberg Finance L.P., acting through its operating agent, erroneously executed a purported (but in fact void *ab initio*) assignment of the Trademarks from BRAIS to Bloomberg Finance L.P., which was recorded at reel/frame number 5927/0202 (the "Void Assignment").

5. BRAIS (now known as BISL) has been, was at all times, and continues to be, the true and correct owner of the entire right, title and interest of the Trademarks identified in the Void Assignment and the Void Assignment should not be deemed to have altered the chain of title of the Trademarks.
