1.1. RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST ("Release"), effective January 23, 2017, is made by ABL ALLIANCE, LLLP, successor in interest to VIRGINIA COMMERCIAL FINANCE, INC., Lender ("Lender") under that certain Loan and Security Agreement, dated as of December 16, 2014, between Atlantic Coast Media Group, LLC ("Borrower") and Lender (as amended, restated, supplemented, or otherwise modified from time to time, including all schedules thereto, "Credit Agreement"; terms used but not defined in this Release shall have the meanings set forth in the Credit Agreement).

Lender agreed to make financial accommodations to Borrower pursuant to the Credit Agreement. In connection with the Credit Agreement, certain subsidiaries of Borrower, as Guarantors (each a "Grantor" and, collectively, "Grantors"), entered into guaranty agreements and intellectual property security agreements (collectively, "Security Agreements"), including (i) that certain Subsidiary Guaranty Agreement dated as of December 16, 2014, and (ii) that certain Trademark Security Agreement (Subsidiary) dated as of December 16, 2014. In accordance with the Security Agreements, Grantors granted a security interest in all right, title, and interest in, to, and under *inter alia* that certain United States trademark filed in the United States Patent and Trademark Office, identified as "SARAH MCNAMARA BEAUTY NEW YORK," Registration No. 4290037, in connection with "Non-medicated skin serums, non-medicated skin balms, non-medicated skin lotions, cosmetics, lipstick" in Class 3 ("Released Trademark Collateral"). Lender desires to release its security interest in and to the Released Trademark Collateral.

THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby terminates, releases, and discharges without representation, recourse, or warranty whatsoever, all of its security interest in and to all of its right, title, and interest in, to, and under the Released Trademark Collateral granted pursuant to the Security Agreements; and Lender hereby retransfers and reassigns any and all such right, title, and interest (if any) that Lender may have in, to, and under the Released Trademark Collateral to the applicable Grantor.


