The Assignee wishes to acquire the Assignor's rights in the Trademarks and common law trademark rights for the Trademarks listed in this agreement.


The Assignee agrees to pay the Assignor \$1 US dollar (one US dollar only) (the receipt of which is hereby acknowledged).
