TO THE
ARTICLES *of* INCORPORATION
of
KOHLER INTERIORS FURNITURE COMPANY


Pursuant to § 55-10-06 of the General Statutes of North Carolina, the undersigned corporation hereby submits the following Articles of amendment for the purpose of amending its Articles of Incorporation:

1. The name of the corporation is KOHLER INTERIORS FURNITURE COMPANY.
2. The Articles of Incorporation are hereby amended by deleting the text of Item no. 1 in its entirety and by substituting therefor the following Item no. 1:

“1. The name of the Corporation is BAKER INTERIORS FURNITURE COMPANY.”
3. The amendment does not provide for an exchange, reclassification, or cancellation of issues shares.
4. The date of adoption of the amendment is February 28, 2017.
5. The amendment was approved by shareholder action, and such shareholder approval was obtained as required by Chapter 55 of the North Carolina General Statutes.
6. These articles will be effective as of February 28, 2017.
