TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of April 13, 2017, by Greek Holdco (Debt), LLC, as administrative agent (the "Administrative Agent"), in favor of Chobani, LLC, a Delaware limited liability company, (the "Grantor"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement or Trademark Security Agreement, as applicable (each defined below).

WITNESSETH:

WHEREAS, Grantor and Administrative Agent were parties to that certain Security and Pledge Agreement dated as of April 23, 2014 (the "Security Agreement"), and that certain Notice of Grant of Security Interest in Trademarks dated as of April 23, 2014 (the "Trademark Security Agreement"), pursuant to each of which the Grantor mortgaged, pledged and hypothecated to the Administrative Agent for the benefit of the holders of the Secured Obligations a continuing security interest in, and a right to set off against, any and all right, title and interest of such Grantor in all of the Trademark Licenses and Trademarks (the "Trademark Collateral"), as set forth on Schedule A hereto;

WHEREAS, the Grantor executed and delivered the Trademark Security Agreement, which was recorded with the Trademark Division of the U.S. Patent & Trademark Office on April 24, 2014, at Reel 5267 and Frame 0325; and

WHEREAS, the Grantor has satisfied and fulfilled all of its obligations to release the Administrative Agent's security interest in the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged by the parties to the Security Agreement:

1. The Administrative Agent, on behalf of the holds of the Secured Obligations, hereby terminates, releases and discharges its mortgage, pledge and hypothecation, and Lien on and security interest in all of Grantor's right, title and interest in, to and under the Trademark Collateral, including the Trademarks set forth on Schedule A hereto.

2. The Administrative Agent hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by the Administrative Agent, any and all of the Administrative Agent's right, title and interest in, to and under the Trademark Collateral.

3. The Administrative Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release and reassignment of the security interest contemplated hereby.
