RELEASE OF SECURITY INTEREST AGREEMENT

WHEREAS, MEETME, INC., a Delaware corporation (“Grantor”), granted a continuing security interest and mortgage to Venture Lending & Leasing VI, Inc. (“VLL6”) and Venture Lending & Leasing VII, Inc. WHEREAS, Grantor has requested that the Secured Party release and reassign its interest in the Patent and Trademarks;


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Secured Party hereby:
