FIRST AMENDMENT TO  
TRADEMARK SECURITY AGREEMENT

THIS FIRST AMENDMENT TO TRADEMARK SECURITY AGREEMENT (this "Amendment"), dated as of February 28, 2017, is entered into by NELSON NAME PLATE COMPANY, a California corporation, dba NELSON-MILLER, INC. ("Grantor"), and EAGLE FUND II, L.P., a Missouri limited partnership ("Secured Party"), with reference to the following facts:

RECITALS

A. The Grantor and the Secured Party are parties to the Trademark Security Agreement, dated as of November 25, 2013 (the "Trademark Security Agreement"), pursuant to which the Grantor granted the Secured Party a security interest in all of its Trademarks and related collateral. The Trademark Security Agreement was recorded in the United States Patent and Trademark Office on December 13, 2013 at Reel/Frame 5168/0599.

B. The Trademark Security Agreement was executed and delivered in connection with an Amended and Restated Senior Subordinated Credit Agreement dated as of April 22, 2011 between Grantor and Secured Party.

C. Since the filing of the Trademark Security Agreement, the Grantor has acquired additional Trademarks.

D. The Grantor and the Secured Party wish to amend the Trademark Security Agreement to add the new Trademarks to Schedule I to the Trademark Security Agreement in order to make such Trademarks part of the Trademark Collateral under the Trademark Security Agreement.

NOW, THEREFORE, the parties hereby agree as follows:

1. Defined Terms. Any and all initially capitalized terms used in this Amendment (including, without limitation, in the recitals hereto) without definition shall have the respective meanings specified in the Trademark Security Agreement. The Trademark Security Agreement is hereby amended such that the definitions set forth in this Amendment shall be incorporated therein by this reference.

2. Addition of New Trademarks. Schedule I to the Trademark Security Agreement is hereby amended and supplemented by adding the Trademarks identified in the Supplement to Schedule I attached to this Amendment, as Trademarks and as part of the Trademark Collateral. Grantor hereby grants to Secured Party a security interest in such Trademarks and Trademark Collateral.

3. No Other Amendments. Except as expressly amended hereby, the Trademark Security Agreement shall remain unaltered and in full force and effect.


