NUNC PRO TUNC ASSIGNMENT OF TRADEMARKS

Assignor hereby irrevocably constitutes and appoints Assignee and its successors, legal representatives and assigns the true and lawful attorneys of Assignor, with full power of substitution, in the name of Assignor or Assignee but on behalf of and for the benefit of Assignee and its successors, legal representatives and assigns, and at the sole expense of Assignee, to institute, prosecute, compromise, defend and settle any and all proceedings at law, in equity or otherwise that and its successors, legal representatives or assigns may deem proper in order to collect, assert or enforce any claim, right or title of any kind in or to any property rights of Assignor in the Trademarks, including the right to sue for past infringement of the Trademarks, and to do all such acts and things in relation thereto and as its successors, legal representatives or assigns, shall deem desirable. Assignor shall fully cooperate with and assist Assignee in such proceedings. Assignor hereby declares that the appointment hereby made and the powers hereby granted are coupled with an interest and are and shall be irrevocable and perpetual and shall not be terminated by any act of Assignor or by operation of law, or by the occurrence of any other event, including, without limitation, the bankruptcy of Assignor, or in any other manner or for any other reason.

DECLARATION UNDER TMEP §503.06(c) IN SUPPORT OF REQUEST
FOR CORRECTION OF ERRORS IN THE PREVIOUSLY RECORDED ASSIGNMENT

Mark Lerner, being hereby warned that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code, and that such willful false statements may jeopardize the validity of this document and the registration to which it relates, declares that:

1. I am a partner in the firm Satterlee Stephens LLP, counsel to Hudson Group (HG) Retail LLC (“Retail”) the successor-in-interest to Hudson News Company (“News”). I am authorized to make this declaration on behalf Hudson in connection with the filing of request for a correction in the recordation for the above-referenced marks.
2. On or about March 31, 2010, News merged into Retail, with Retail the surviving entity.
3. A recordation of the Certificate of Merger of a Foreign Corporation into a Delaware Limited Liability Company dated March 31, 2010 (the “Merger”) was filed on September 1, 2010 at Reel: 004270 / Frame: 0975. Although, pursuant to the merger News merged into Retail, which was the surviving company, and that merger would have, on its face, resulted in the ownership by Retail of the trademarks listed, in actuality, it did not impact the trademarks. The merger postdated an earlier assignment by News to another related entity, Hudson Group (HG) Inc. (“Group”). The assignment had been authorized by a “Consent in Lieu

of Meeting of Board of Directors” to be effective as of January 4, 2010. A Nunc Pro Tunc assignment, confirming the assignments and effective as of January 10, 2010 has been prepared and is being recorded herewith.

4. At the time of the recordation, however, which was instructed by Retail, we were unaware of the prior assignment from News to Group and that assignment had not been filed and recorded. Retail does not hereby assert that it is the proper owner and does not claim that it is a good faith transferee that owns the mark due to the prior assignment not having been recorded.

5. Retail and Group submit that a corrective recordation is appropriate here since effectively the interest was filed in error and recorded by Retail against News’s marks as outlined in TMEP §503.06(c).

6. The various Hudson entities all submit that Retail did not become the owner of the marks by virtue of the Merger, and that Group was and is the correct owner of record based on the Nunc Pro Tunc assignment submitted herewith.
