#### RELEASE OF TRADEMARK SECURITY AGREEMENT

This Release of Trademark Security Agreement (this "Release") is made as of April 12, 2017, by U.S. BANK NATIONAL ASSOCIATION, in its capacity as Collateral Agent for the Lenders under (and as defined in) the Indenture referred to below (the "Collateral Agent") for the benefit of COMMERCIAL VEHICLE GROUP, INC., CABARRUS PLASTICS, INC., CVG CS LLC, CVG ALABAMA, LLC, CVG MANAGEMENT CORPORATION, CVG LOGISTICS, LLC, CVG EUROPEAN HOLDINGS, LLC, CVG OREGON, LLC, CVG CVS HOLDINGS, LLC (f/k/a CVS HOLDINGS, INC.), MAYFLOWER VEHICLE SYSTEMS, LLC, CVG MONONA, LLC (f/k/a MONONA CORPORATION), CVG MONONA WIRE, LLC (f/k/a MONONA WIRE CORPORATION), MONONA (MEXICO) HOLDINGS LLC, CVG NATIONAL SEATING COMPANY, LLC (f/k/a NATIONAL SEATING COMPANY, INC.), and CVS SPRAGUE DEVICES, LLC (f/k/a SPRAGUE DEVICES, INC.), TRIM SYSTEMS, INC., and TRIM SYSTEMS OPERATING CORP. (the "Grantors"). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Indenture.

WHEREAS, the Grantors and the Collateral Agent are parties to that certain (i) Indenture, dated as of April 26, 2011 (as amended, restated or otherwise modified through the date hereof, the "Indenture"); and (ii) Trademark Security Agreement, dated as of April 26, 2011 (as amended, restated or otherwise modified through the date hereof, the "Trademark Security Agreement"), pursuant to which the Grantors have granted to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in all of the right, title and interest of the Grantors in, to and under the Trademark Collateral, including the trademarks set forth on Schedule I hereto, and all goodwill relating to such trademarks;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on May 17, 2011 at Reel 4543 and Frame 0001; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. The Collateral Agent does hereby terminate, release and discharge the entirety of any and all liens or security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Indenture or Trademark Security Agreement to the Trademark Collateral and any right, title or interest of the Collateral Agent in such Trademark Collateral and goodwill relating thereto shall hereby terminate, cease and become void. The Collateral Agent hereby assigns, transfers and conveys any and all right, title or interest of the Collateral Agent in the Trademark Collateral to the Grantors.

- 2. This Release may be executed in any number of counterparts (including electronic transmission and facsimile counterparts), each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.
- 3. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.
