TERMINATION AND RELEASE OF PATENT AND TRADEMARK SECURITY AGREEMENT

This Termination and Release of Patent and Trademark Security Agreement is effective as of April 14, 2017, by WELLS FARGO BANK, NATIONAL ASSOCIATION (including its London Branch and its successors and assigns, "Wells Fargo") having an address at 2450 Colorado Avenue, Suite 3000W, Santa Monica, California 90404.

WHEREAS, that certain Patent and Trademark Security Agreement, dated as of August 29, 2014, (as heretofore amended, restated, supplemented or otherwise modified, the "Patent and Trademark Security Agreement"), was executed in favor of Wells Fargo by MILLENNIAL BRANDS LLC (f/k/a ROCKET DOG BRANDS LLC), a Delaware limited liability company ("Company") pursuant to which the Company granted to Wells Fargo a security interest in, to and under the following, whether then existing or thereafter created or acquired (collectively, the "IP Collateral");

(a) all of Company's Patents, including, without limitation, those referred to on Exhibit A hereto; and

(b) all of Company's Trademarks, including, without limitation, those referred to on Exhibit B hereto;

WHEREAS, the Patent and Trademark Security Agreement was recorded with the U.S. Patent and Trademark Office on September 19, 2014, at Reel 5365, Frame 0902;

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Agent agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Patent and Trademark Security Agreement.


