**AMENDED AND RESTATED  
ARTICLES OF INCORPORATION  
OF  
CHURCH COMMUNITY BUILDER, INC.**

The directors and shareholders of this corporation have adopted these Amended and Restated Articles of Incorporation (these "Articles"), as permitted pursuant to §7-110-103 and §7-110-107 Colorado Revised Statutes ("C.R.S."), and authorize the delivery of these Articles to the Colorado Secretary of State for filing.

**ARTICLE I  
NAME**

The name of the corporation is Church Community Builder, Inc.

**ARTICLE II  
PURPOSE**

The corporation shall have and may exercise all of the rights, powers and privileges now or hereafter conferred upon corporations organized under the laws of Colorado except that the corporation shall not act as a bank, trust company, insurance company or health care cooperative. In addition, the corporation may do everything necessary, suitable or proper to accomplish any of its corporate purposes. The corporation may conduct part or all of its business in any part of Colorado, the United States or the world and may hold, purchase, mortgage, lease, and convey real and personal property in any of such places.

**ARTICLE III  
CAPITAL STOCK**

The corporation is authorized to issue one class of stock, which is Common Stock. The aggregate number of shares that the corporation shall have authority to issue is One Hundred (100) shares of Common Stock. Each share of Common Stock shall have one vote in the election of directors and all other matters and shall constitute the sole voting group of the corporation, except to the extent any additional voting group or groups may hereafter be established in accordance with the Colorado Business Corporation Act.

**ARTICLE IV  
NO CUMULATIVE VOTING OR PREEMPTIVE RIGHTS**

The shareholders shall not be entitled to cumulative voting. The shareholders shall not be entitled to preemptive rights to acquire additional or treasury shares of this corporation.

**ARTICLE V  
QUORUM**

Unless otherwise ordered by a court of competent jurisdiction, at all meetings of



shareholders, fifty percent (50%) of the shares of a voting group entitled to vote at such meeting, represented in person or by proxy, shall constitute a quorum of that voting group.

**ARTICLE VI**  
**ACTION BY SHAREHOLDERS WITHOUT A MEETING**

Any action required or permitted to be taken at a shareholders' meeting may be taken without a meeting if the required shareholders consent to such action in writing. The required shareholders are the shareholders holding shares having not less than the minimum number of votes that would be necessary to authorize or take such action at a meeting at which all of the shares entitled to vote thereon were present and voted. The corporation shall provide notice of all actions taken by less than unanimous written consent as required by the corporation's bylaws or by statute.

**ARTICLE VII**  
**DIRECTORS**

The number of directors of the corporation shall be fixed by the bylaws, or if the bylaws fail to fix such a number, then by resolution adopted from time to time by the board of directors.

**ARTICLE VIII**  
**REGISTERED OFFICE AND AGENT**

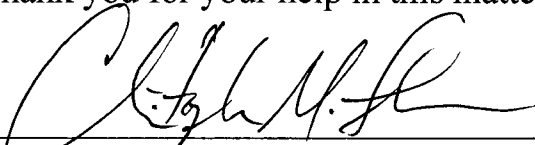

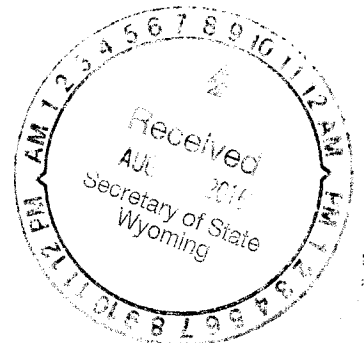

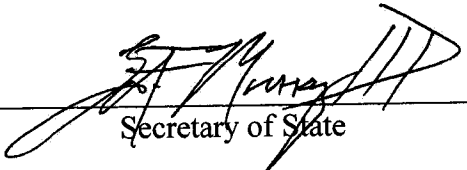
