RELEASE OF SECURITY INTEREST IN CERTAIN TRADEMARK

THIS PARTIAL RELEASE dated as of April 11, 2017 (this "Release") is made by Comerica Bank, a Texas banking association and authorized foreign bank under the *Bank Act* (Canada) (the "Secured Party") under the Intellectual Property Security Agreement dated November 14, 2008 (as amended, restated, supplemented or otherwise modified from time to time,, the "Security Agreement") between VIXS Systems Inc., a company existing under the *Business Corporations Act* (Ontario) (the "Debtor") and the Secured Party, and recorded in the records of the United States Patent and Trademark Office on July 18, 2016, at Trademark Reel 005835, Frame 0967.

WHEREAS, pursuant to the Security Agreement, the Debtor granted to the Secured Party a security interest in the Debtor's trademarks (the "Trademarks"), including the trademark Registration Number 4,265,197 (the "Released Trademark").

WHEREAS, the Secured Party wishes to: (i) release all of its security interest covering the Released Trademark, only; (ii) restore all right, title and interest in and to the Released Trademark to the Debtor; and (iii) dissolve any and all liens and encumbrances respecting the Released Trademark under the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release its security interest in the Released Trademark, and discharges, quit claims and relinquishes unto the Debtor (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Released Trademark under the Security Agreement.
