## AFFIDAVIT

I, the undersigned Nicole M. Murray, Illinois bar member and counsel for Assignee, having firsthand knowledge regarding the ownership of CABELA'S (Reg. No. 1151981), CABELA'S CLUB (Reg. No. 2116567), CABELA'S & Design (Reg. No. 2163936), CABELA'S.COM (Reg. No. 2247977), and CABELAS (Reg. No. 3130554) ("Marks") solemnly and sincerely declare as follows:

1. The assignment document dated September 19, 2006 transferring ownership of the Marks from  
Cabela's Incorporated, a Nebraska corporation ("Assignor") to  
Cabela's Incorporated, a Delaware corporation ("Assignee"), inadvertently listed the Assignor as Cabela's Inc., a Nebraska corporation, rather than Cabela's **Incorporated**, a Nebraska corporation.


This same assignment document also inadvertently listed Assignee as Cabela's Inc., a Delaware corporation, rather than Cabela's **Incorporated**, a Delaware corporation;

2. Cabela's Inc., a Nebraska corporation, is merely an abbreviated trade name of Cabela's Incorporated, a Nebraska corporation, as the result of a minor clerical error; and
3. Cabela's Inc., a Delaware corporation, is merely an abbreviated trade name of Cabela's Incorporated, a Delaware corporation, as the result of a minor clerical error.

Assignee respectfully requests that the identity of the Assignor and Assignee in the United States Patent and Trademark Office assignment records be corrected so as to name the respective legal entities, Cabela's Incorporated, a Nebraska corporation, and, Cabela's Incorporated, a Delaware corporation, rather than the abbreviated trade names of those entities. *See* T.M.E.P. § 503.06(b) (permitting correction of errors in recorded assignment documents); *see also*, T.M.E.P. § 1201.02(e) ("Minor clerical errors . . . in the applicant's name may be corrected by amendment, as long as this does not result in a change of entity").




