TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of April ~~16~~<sup>10</sup>, 2017, and made by **GENERAL ELECTRIC COMPANY**, as Administrative Agent (as successor in interest by merger to General Electric Capital Corporation, as Administrative Agent) ("Grantee") to **CHILDCARE EDUCATION INSTITUTE, LLC**, a Georgia limited liability company ("Grantor").

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged Grantee hereby states as follows:


1. Definitions. All terms not herein defined, have the meanings set forth in the Security Agreement referenced above.

Grantee hereby terminates the Security Agreement and terminates, releases and discharges any security interest in and lien upon the Trademarks and other Trademark Collateral, and reassigns, transfers, and conveys to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks and other Trademark Collateral.
