## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated as of June 17, 2014 (the "Release") is made by Comerica Bank, as agent for certain financial institutions (the "Secured Party"), in favor of Envirite of Ohio, Inc. (the "Debtor"), pursuant to the Agreement (Trademark) dated as of May 18, 2010 (as amended, restated or otherwise modified from time to time, the "Security Agreement") by and between the Secured Party and the Debtor and recorded in the records of the United States Patent and Trademark Office on May 26, 2010 at Trademark Reel 004213, Frame 0045.

WHEREAS, pursuant to the security agreement dated November 25, 2008, the Debtor granted to the Secured Party a security interest in the Trademark Collateral (as defined in the Security Agreement), including but not limited to the trademarks listed on the attached Exhibit A (collectively, the "Trademarks").

WHEREAS, the Debtor has satisfied the terms of the Security Agreement and the Secured Party wishes to: (i) release and terminate all of its security interest in the Trademark Collateral; (ii) restore all right, title and interest in and to the Trademark Collateral to the Debtor; and (iii) terminate any and all liens and encumbrances respecting the Trademark Collateral under the Security Agreement.


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release and terminate its security interest in the Trademark Collateral, including the Trademarks, and discharge, quit claim and relinquish unto the Debtor (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Trademark Collateral, including the Trademarks, together with the goodwill of the business symbolized thereby, under the Security Agreement.

This Release shall be governed by, and construed and interpreted in accordance with, the internal laws of the State of Michigan.



