RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT, dated March 31, 2017, is made in favor of **U.S. INDUSTRIAL TOOL AND SUPPLY COMPANY**, a Delaware corporation whose principal place of business and mailing address is 14083 South Normandie Avenue, Gardena, California 90249 ("Debtor"), by **FIFTH THIRD BANK**, an Ohio banking corporation, for itself and as agent for each affiliate of Fifth Third Bancorp to whom Obligations are owed from time to time (collectively, "Secured Party"). WHEREAS, Secured Party and Debtor, are parties to that certain Security Agreement;

WHEREAS, the Security Agreement granted to Secured Party a continuing security interest in and to, all of Debtor's rights, titles and interests in and to all of its Trademark Collateral, including without limitation the Trademark listed on Schedule I attached hereto; and

WHEREAS, Secured Party desires to release its rights and security interests in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby fully and finally releases and terminates its security interest in and to all other rights in and to the Trademark Collateral. Secured Party agrees, at the Debtor's expense, to take all further actions, and provide to the Debtor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Debtor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release of Trademark Security Agreement.
