RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of April 20, 2017 (the "Effective Date") by BANK OF AMERICA, N.A., as Administrative Agent ("Grantee"), in favor of RUDOLPH AND SLETTEN, INC., a California corporation, BRICE BUILDING COMPANY, LLC, a Delaware limited liability company, and FISK ELECTRIC COMPANY, a Texas corporation (collectively, "Grantors").

WHEREAS, pursuant to the terms and conditions of that certain Fifth Amended and Restated Security Agreement by and among Grantors, Grantee and the other parties thereto dated June 5, 2014 (the "Security Agreement"), each Grantor granted to Grantee a continuing security interest in and to all of such Grantor's right, title and interest in and to all of the trademarks set forth on Schedule A attached hereto (together with all other rights granted in respect of such trademarks, collectively, the "Trademarks");

WHEREAS, Grantee's continuing security interest in the Trademarks is evidenced by the filing of that certain Notice of Grant of Security Interest in Trademarks, by and among Grantors and Grantee dated June 5, 2014 (the "Trademark Security Agreement"), and recorded with the United States Patent and Trademark Office (the "PTO") on June 10, 2014 at Reel/Frame 005299/0303; and

WHEREAS, Grantors and Grantee entered into the Security Agreement pursuant to the terms and conditions of that certain Sixth Amended and Restated Credit Agreement by and among Grantors, Grantee and the other parties thereto dated June 5, 2014 (the "Credit Agreement").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby terminates, cancels and releases any and all security interests it has against the Trademarks granted pursuant to the Security Agreement and the Trademark Security Agreement and releases all other rights it may have to the Trademarks under the Security Agreement and the Trademark Security Agreement.

2. Grantee, to the extent granted in the Security Agreement or the Trademark Security Agreement, hereby assigns, grants and otherwise re-conveys to Grantor, without any representation, recourse or undertaking by Grantee, all of its right, title and interest in and to the Trademarks and all goodwill associated therewith originally granted to Grantee pursuant to the Security Agreement or the Trademark Security Agreement.


3. Grantee shall, at Grantors' expense, take all further actions, and provide to Grantors, their respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantors to more fully and effectively effectuate the purposes of this Release and authorizes the Grantors (or their designees) to have this Release recorded with the PTO.
