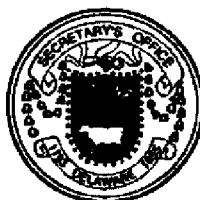

**FIRST:** The name of the limited liability company is Buccaneers Team LLC.

**SECOND:** The address of its registered office in the State of Delaware is: Corporation Trust Center, 1209 Orange Street, in the City of Wilmington, Delaware 19801. The name of its Registered Agent at such address is: The Corporation Trust Company.

**THIRD:** The latest date on which the limited liability company is to dissolve is: None.

**FOURTH:** National Football League policy has limitations on the number and type of persons who may have ultimate direct, indirect, beneficial, contingent or other interests in the Tampa Bay Buccaneers franchise (the "Franchise") and related assets and prohibits any direct or indirect sale, transfer, assignment, pledge, hypothecation, encumbrance or other disposition of, or with respect to, the Franchise and such related assets or any direct or indirect interest therein without the prior written consent of the National Football League, unless specifically exempted from such consent pursuant to the Constitution and Bylaws of the National Football League. Please contact the National Football League, League Counsel, 345 Park Avenue, New York, New York 10154 to determine the applicable requirements.

**FIFTH:** Precedence of League Policies.

Notwithstanding any agreement to the contrary, this certificate and any and all other arrangements between or among the members or any entity that has any interest, direct or indirect, in any member which relates to the ownership or operation of the Tampa Bay Buccaneers franchise (the "Franchise"), are subject to the NFL Rules in all respects. In the event of any inconsistency or conflict between the terms and provisions of this Certificate and those contained in the NFL Rules, the terms and provisions of the NFL Rules shall control. This Section Fifth, the definition of the NFL Rules and any other provision hereof affecting the rights of the National Football League may not be amended, waived or otherwise adversely affected without the prior written consent of the National Football League, in its sole discretion, which such League is a third-party beneficiary of the covenant and agreement reflected in this Section. The members will provide copies of any proposed amendments or waivers hereto to the National Football League, 345 Park Avenue, New York, N.Y. 10154, Attn: League Counsel.

Each member shall (and, in the case of each party that is an entity, shall cause its governing documents and its respective stockholders, partners, members and control persons to), comply at all times with all applicable NFL Rules, including all NFL Rules relating to transfers of direct or indirect ownership interests in an NFL member club, the incurrence of indebtedness and the confidentiality of certain information relating to the NFL,

the Club or other NFL member clubs (which may include information that such party is expressly entitled to receive under this Agreement or applicable law).

As used herein, "NFL Rules" means the Constitution and Bylaws of the NFL, including without limitation, all resolutions, rules and policies adopted and/or promulgated thereunder, and the Articles of Association and Bylaws of the NFL Management Council, including any amendments to either such document and any interpretations of either such document issued from time to time by the Commissioner which are within the Commissioner's jurisdiction; all operative NFL or NFL Management Council resolutions that are within the NFL's or the NFL Management Council's respective jurisdictions; any existing or future agreements entered into by the NFL or the NFL Management Council, including without limitation, any television agreements or any collective bargaining or other labor agreements (including without limitation, any NFL player salary guarantees and pension fund agreements), and any agreements made in settlement of any litigation against the NFL, the NFL Management Council, or the NFL member clubs (including litigation against such clubs, or agreements made by such clubs, jointly or collectively); any agreements and arrangements to which such member is or after the date of this Agreement may become subject or by which it or its assets are or may become bound with or in favor of the NFL and its affiliates; and such other rules or policies as the NFL, the NFL Management Council, or the Commissioner may issue from time to time that are within the issuing party's jurisdiction, including without limitation, all financial and other reporting requirements of the NFL.
