TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of April <sup>16</sup>/<sub>6</sub>, 2017, and made by **GENERAL ELECTRIC COMPANY** (as successor in interest by merger to General Electric Capital Corporation), as Administrative Agent ("Grantee") to, **REALLY GOOD STUFF, LLC**, a Delaware limited liability company ("Grantor").

**WHEREAS**, pursuant to that certain Trademark Security Agreement dated as of January 19, 2016, made by Grantor in favor of Grantee (the "Security Agreement"), the Grantor granted to the Grantee, among other collateral as set forth therein, a security interest in all of the Grantor's right, title and interest in, to and under the United States trademarks registrations and applications listed on the attached Schedule A, including any goodwill of the business connected with the use of, and symbolized by the trademarks (the "Trademarks");

**WHEREAS**, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on January 19, 2016, at Reel 5712 and Frame 0153; and

**WHEREAS**, Grantee now desires to terminate and release the Security Agreement;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged Grantee hereby states as follows:


1. Definitions. All terms not herein defined, have the meanings set forth in the Security Agreement referenced above.
