NOW, THEREFORE, Lancope and Cisco agree as follows and confirm that:



Lancope has assigned and transferred, and Cisco has received and accepted, all of Lancope's rights, title and interest throughout the world in and to the Lancope Marks and all the rights, claims and privileges pertaining to the Lancope Marks, including without limitation: the registrations and applications pertaining thereto, together with all of the goodwill of the business associated with and symbolized by the Lancope Marks; and the right to sue and recover damages for past, present and future infringements thereof and to stand in the place of Lancope in all matters related thereto.

Lancope hereby authorizes and requests the United States Commissioner of Patents and Trademarks and the relevant officials of foreign countries to implement this Assignment.

IN WITNESS WHEREOF, Lancope and Cisco have caused this Assignment to be made as of the effective date of the Asset Transfer Agreement referenced above.
