NOW, THEREFORE, Heroik and Cisco agree as follows and confirm that:



Heroik has assigned and transferred, and Cisco has received and accepted, all of Heroik's rights, title and interest throughout the world in and to the Heroik Marks and all the rights, claims and privileges pertaining to the Heroik Marks, including without limitation: the registrations and applications pertaining thereto, together with all of the goodwill of the business associated with and symbolized by the Heroik Marks; and the right to sue and recover damages for past, present and future infringements thereof and to stand in the place of Heroik in all matters related thereto.


Heroik hereby authorizes and requests the United States Commissioner of Patents and Trademarks to record this Assignment.
