CONFIRMATION OF TRADEMARK ASSIGNMENT

Cisco has assigned and transferred, and CTI has received and accepted, all of Cisco's rights, title and interest throughout the world in and to the Cisco Marks and all the rights, claims and privileges pertaining to the Cisco Marks, including without limitation: the registrations and applications pertaining thereto, together with all of the goodwill of the business associated with and symbolized by the Cisco Marks; and the right to sue and recover damages for past, present and future infringements thereof and to stand in the place of Cisco in all matters related thereto.

Cisco hereby authorizes and requests the United States Commissioner of Patents and Trademarks to record this Assignment.

IN WITNESS WHEREOF, Cisco and CTI have caused this Assignment to be made as of the effective date of the Asset Transfer Agreement referenced above.
