TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination") is dated as of April 24, 2017, and made by WF FUND V LIMITED PARTNERSHIP (c/o/b as WELLINGTON FINANCIAL LP and WELLINGTON FINANCIAL FUND V) ("Secured Party"), to EXINDA INC., a Delaware corporation ("Grantor").

WHEREAS, certain security interests (the "Interests") were granted by the Grantor to the Secured Party in certain collateral, including the Trademarks (as hereinafter defined), pursuant to that certain Trademark Security Agreement, dated as of April 19, 2016, by the Grantor in favor of the Secured Party;

WHEREAS, the Interests were recorded by the Assignment Recordation Branch of the United States Patent and Trademark Office on April 20, 2016, at Reel 5774/Frame 0195; and

WHEREAS, the Secured Party now desires to terminate and release the Interests.

NOW, THEREFORE, for good and valuable consideration, the Secured Party hereby states as follows:

1. Definitions. The term "Trademarks," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in all of its trademarks, trademark applications, service marks and trademark licenses, including those listed on Schedule A hereto.

2. Release of Security Interest. The Secured Party hereby terminates the Interests, and terminates, releases, and discharges all its right, title, and interest in the Trademarks.
