ASSIGNMENT OF TRADEMARKS

This Assignment of Trademarks (this "Assignment") is made as of this _____ day of June, 2016 (the "Effective Date"), by and between Granite Gaming Group I, LLC, a Nevada limited liability company ("Granite Group I"), Granite Gaming Group III, LLC, a Nevada limited liability company ("Granite Group III") (collectively, the "Assignor") and DROCK Gaming, LLC, a Nevada limited liability company ("Assignee").

RECITALS

A. Granite Group I is the holder of both a federally registered trademark which was registered on or about October 13, 2009, with the United States Patent and Trademark Office ("USPTO") as Registration No. 3,694,978, and a State of Nevada registered trademark, pursuant to Document No. 20140012069-75, filed with the Nevada Secretary of State on or about January 7, 2014 for the service mark "MERMAIDS."

B. Granite Group III is the holder of both a federally registered trademark which was registered on or about August 11, 2009, with the USPTO as Registration No. 3,666,030, and a State of Nevada registered trademark, pursuant to Document No. 20140012066-42, filed with the Nevada Secretary of State on or about January 7, 2014 for the service mark "LA BAYOU" (together with MERMAIDS, the "Trademarks").

C. Assignor and Assignee entered into that certain Asset Purchase Agreement, dated April 20, 2016 (the "Purchase Agreement") pursuant to which Assignor, as owners of the Trademarks, desire to assign the Trademarks to Assignee.

D. Assignee desires to obtain all right, title and interest in and to the Trademarks, including any causes of action relating to the Trademarks.

E. Capitalized terms used herein but not defined shall have the same meaning as ascribed to them in the Purchase Agreement.

NOW, THEREFORE, for good and valuable consideration, the full receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the parties agree as follows:

1. Subject to and without limiting the representations, warranties, covenants and limitations set forth in the Purchase Agreement, Assignor hereby sells, assigns, transfers, and conveys to Assignee all of its right, title, and interest, whether statutory or common law, in and to the Trademarks, including the goodwill represented by the Trademarks, all income, royalties, damages, and payments now or hereafter due or payable with respect thereto, and to any causes of action, claims for damages, profits and costs, both in equity and in law, relating to said Trademarks, and the right to sue, counterclaim, and recover damages for past, present, and future infringement, misappropriation, or violation of the rights assigned or to be assigned under this Assignment.

2. Subject to and without limiting the representations, warranties, covenants and limitations set forth in the Purchase Agreement, Assignor further hereby covenants, agrees, and undertakes to execute, whenever requested by Assignee, all applications, assignments, lawful oaths and any other papers which Assignee may deem necessary or desirable for securing to Assignee or for maintaining for Assignee the Trademarks hereby assigned, all without further compensation to Assignor.




