
FOR VALUE RECEIVED, the undersigned, **U.S. BANK NATIONAL ASSOCIATION**, a national banking association ("Lender"), having an office at 1349 West Peachtree Street, NW, Suite 1325, Atlanta, Georgia 30309, does hereby release, relinquish, terminate and cancel any and all liens and security interests granted to Lender, by Company (as defined below), in and to the trademarks listed on Schedule A attached hereto (collectively, the "Trademark Collateral"), arising under that certain (i) Trademark Security Agreement dated August 10, 2015 ("Original Agreement") by and between **CENTRAL NETWORK RETAIL GROUP, LLC**, a Delaware limited liability company, successor-by-merger with MARVIN'S, INC., a Delaware corporation ("Company"), having its chief executive address at 3753 Tyndale Drive, Suite 102, Memphis, Tennessee 38125 and Lender, recorded August 10, 2015, at Reel 5597, Frame 0018, and (ii) Amended and Restated Trademark Security Agreement dated October 19, 2015 ("A&R Agreement"; together with the Original Agreement, the "Trademark Agreement") by and between Company and Lender, recorded October 21, 2015, at Reel 5650, Frame 0518, with the United States Patent and Trademark Office with respect to the Trademark Collateral. This Release of Security Interest in Trademarks (this "Release") may be filed with the United States Patent and Trademark Office to evidence Lender's release of the security interest against such trademarks.

This Release is intended to operate as a release of all liens and security interests in the trademarks listed on Schedule A attached hereto, conveyed by Company to Lender pursuant to the terms of the Trademark Agreement, without any representation, warranty or undertaking by, or recourse to, Lender. If and to the extent Lender has acquired any right, title or interest in and to any of the Trademark Collateral pursuant to the terms of the Trademark Agreement, Lender hereby reassigns and transfers such right, title and interest to Company, together with the goodwill of Company's business connected with and symbolized by the Trademark Collateral, without any representation, warranty or undertaking by, or recourse to, Lender.
