RELEASE OF TRADEMARK SECURITY INTEREST

WHEREAS, pursuant to that certain GRANT OF SECURITY INTEREST -- TRADEMARKS, dated as of June 10, 2016 (the "Trademark Security Agreement"), recorded in the United States Patent and Trademark Office at Reel 5812, Frame 0425, each of Centerra Group, LLC ("CG"), and Gregg Protection Services, LLC ("GPS", together with CG each a "Releasee" and collectively, the "Releasees"), pledged and granted to Cerberus Business Finance, LLC, in its capacity the collateral agent for itself and other Secured Parties (together with its successors and assigns in such capacity, the "Releasor"), for the benefit of the Releasor and Secured Parties, a continuing security interest in all right, title and interest of each such Releasee in, to and under the trademarks and service marks listed opposite each applicable Releasee on the attached Schedule A, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (the "Trademarks"), together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (collectively, the "Collateral") to secure the payment, performance and observance of the Secured Obligations; and

WHEREAS, Releasees have requested and Releasor has agreed to provide this Release of Trademark Security Interest to confirm the release, relinquishment and discharge of its continuing security interest in the Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.
2. Termination and Release of Security Interest. Releasor, on behalf of itself and all Secured Parties, hereby:
 - a. terminates and releases to Releasee its and their continuing security interest in and to the Collateral and terminates the Trademark Security Agreement;
 - b. re-assigns to Releasee, any right, title or interest the Releasor or any Secured Party may have in, to or under the Collateral, together with the goodwill of the business symbolized thereby; and
 - c. authorizes the recordation of this Release of Trademark Security Interest with the United States Patent and Trademark Office, at Releasee's expense.

3. Choice of Law. This Release of Trademark Security Interest shall be governed by and construed in accordance with the laws of the State of New York.
