## TRADEMARK ASSIGNMENT

This Trademark Assignment Agreement (“Agreement”) is made and entered into as of Apr. 6, 2017 (“Effective Date”) by and between NHN CORPORATION (“Assignor”), a corporation organized under the laws of the Republic of Korea, having an address at GREENFACTORY, 6 BULJEONG-RO, BUNDANG-GU, SEONGNAM-SI, GYEONGGI-DO, REPUBLIC OF KOREA, and NHN ENTERTAINMENT CORPORATION (“Assignee”), a corporation organized under the laws of the Republic of Korea, having an address at 16, DAEWANGPANGYO-RO 645 BEON-GIL, BUNDANG-GU, SEONGNAM-SI, GYEONGGI-DO, 13487, REPUBLIC OF KOREA. Assignor and Assignee are sometimes individually referred to herein as a “Party,” and collectively as the “Parties.”

WHEREAS, Assignor, has adopted, used, is using and is the owner of all right, title and interest in and to the trademarks and the corresponding registration number 4,409,421 (“Trademark”), together with the goodwill of the business connected with and symbolized by the Trademarks; and

WHEREAS, Assignee desires to acquire all right, title and interest in and to the Trademarks and registrations and applications thereof together with the associated business and goodwill.


NOW, THEREFORE, in exchange for good and valuable consideration under this Agreement and related transactional documents, the receipt and sufficiency of which Assignor hereby acknowledges, and as a condition to Assignee entering into the Agreement, the Parties hereby agree as set forth below.

1. Assignor hereby sells, assigns, transfers and conveys to Assignee the entire right, title, interest in and to the Trademarks in the United States and all jurisdictions outside the United States, together with the goodwill of the business connected with and symbolized by the Trademarks (including, without limitation, the right to renew any registrations included in the Trademarks, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Trademarks, and any priority right that may arise from the Trademarks), the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor had this sale, assignment, transfer and conveyance not been made.
2. Assignor authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and in any applicable jurisdictions outside the United States to record the transfer of said registration to Assignee as assignee of Assignor’s entire right, title and interest therein. Assignor agrees to further execute any documents reasonably necessary to effect this assignment or to confirm Assignee’s ownership of the Trademarks.
3. Assignor hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Assignment.


