## TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT ("IP Assignment"), dated as of 8<sup>th</sup> March 2017, is made by Promius Pharma, LLC ("Assignor") a LIMITED LIABILITY COMPANY DELAWARE 107 College Road East Princeton NEW JERSEY 08540, in favor of Dr. Reddy's Laboratories Limited, ("Assignee"), an Indian corporation, located at 8-2-337, Road No. 3, Banjara Hills, Hyderabad – 500034, Telangana, INDIA.

WHEREAS, the parties hereto have agreed to execute and deliver this IP Assignment, for assignment and recording of the "Assigned TM", more clearly set forth on Schedule I hereto, with the United States Patent and Trademark Office and corresponding entities or agencies in any applicable jurisdictions;

NOW THEREFORE, the parties agree as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor's hereby irrevocably conveys, transfers, and assigns to the Assignee, and Assignee hereby accepts, all of Assignor's right, title, and interest in the Assigned TM in the United States of America:

(a) the trademark registrations and applications and all issuances, extensions, and renewals thereof together with the goodwill of the business connected with the use of, and symbolized by, the Assigned TM; provided that, with respect to the United States intent-to-use trademark applications set forth on Schedule I hereto, the transfer of such applications accompanies, the transfer of Assignor's business, or portion of the business to which the trademark pertains, and that business is ongoing and existing;

(b) all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;

(c) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(d) any and all claims and causes of action, with respect to any of the foregoing, to the extent such claims and causes of action accrue after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recordation and Further Actions. The Assignor hereby authorizes the Commissioner for Patents and the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this IP Assignment upon request by Assignee. Following the date hereof, upon Assignee's reasonable request, and at Assignee's sole cost and expense, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns, and legal representatives, including the execution and

delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence, or perfect the assignment of the Assigned TM to the Assignee, or any assignee or successor thereto.


