## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of April 24, 2017 (this "Release"), is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, in its capacities as administrative agent and collateral agent for the Lenders (in such capacities, the "Agent"), in favor of THE MAJESTIC STAR CASINO, LLC, an Indiana limited liability company (the "Borrower"), MAJESTIC HOLDCO, LLC, a Delaware limited liability company ("Parent"), MAJESTIC MISSISSIPPI, LLC, a Mississippi limited liability company ("Majestic Mississippi") and THE MAJESTIC STAR CASINO II, LLC, a Delaware limited liability company (collectively with the Borrower, Parent and Majestic Mississippi, "Debtor"). Capitalized terms used but not otherwise defined herein shall have the meaning set forth in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Debtor and Agent entered into that certain Trademark Security Agreement, dated as of May 29, 2015 (as amended, restated, amended and restated, replaced, supplemented and/or otherwise modified, the "Security Agreement"), pursuant to which the Debtor pledged and granted to the Agent, for the benefit of the Lender Group and any Permitted LC Issuer, if applicable, a security interest in and to all of its right, title and interest in, to and under the Trademark Collateral owned by Debtor including, without limitation, the trademark registrations and applications listed on Schedule A attached hereto;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on June 4, 2015 at Reel 5545 and Frame 0965; and

WHEREAS, the Debtor has requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in and to the Trademark Collateral.

NOW, THEREFORE, in consideration of the premises, and for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the security interests created under the Security Agreement in the Trademark Collateral, (b) discharge and release its security interest in and to the Trademark Collateral, and (c) reassign any and all rights, title and interest it has in the Trademark Collateral to Debtor.

THIS RELEASE SHALL BE DEEMED TO BE A CONTRACT UNDER THE LAW OF THE STATE OF NEW YORK WITHOUT REGARD TO ITS CONFLICT OF LAWS PRINCIPLES THAT WOULD REQUIRE THE APPLICATION OF ANY OTHER LAW.
