**RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (the "Release"), dated as of April 25, 2017, is made by Comerica Bank, as Collateral Agent (the "Collateral Agent") pursuant to the Collateral Agreement, dated as of March 14, 2014 (as amended, restated, supplemented or otherwise modified through the date hereof, the "Collateral Agreement") among Greektown Mothership LLC, a Delaware limited liability company, Greektown Holdings, L.L.C., a Michigan limited liability company (the "Company"), Greektown Casino, L.L.C., a Michigan limited liability company (the "Pledgor"), certain other subsidiaries of the Company party thereto and the Collateral Agent.

WHEREAS, pursuant to the Collateral Agreement, Pledgor executed the First Lien Trademark Security Agreement dated as of March 14, 2014 (as amended, restated, supplemented or otherwise modified through the date hereof, the "Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office on March 17, 2014 at Reel/Frame No. 5238/0488, pursuant to which the Pledgor granted to the Collateral Agent a security interest in all of its right, title and interest in, to and under the IP Collateral (as defined in the Trademark Security Agreement);



The undersigned hereby transfers and assigns to the Pledgor, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the IP Collateral under the Collateral Agreement and the Trademark Security Agreement.
