1. Assignment. Assignor confirms that on or about October 31, 2014, Assignor did and has assigned to Assignee: (1) all the property, right, title and interest in and to the Trademarks including all common law rights connected therein together with the registration therefor for the United States and throughout the world together with the goodwill of the business in connection with which the Trademarks are used and which is symbolized by the Trademarks; (2) all income, royalties, and damages hereafter due or payable to Assignor with respect to the Trademarks, including without limitation, damages, and payments for past or future infringements and misappropriations of the Trademarks; and (3) all rights to sue for past, present and future infringements or misappropriations of the Trademarks.
2. Acceptance. Assignee hereby acknowledges that it accepted the foregoing assignment for good and valuable consideration on or around October 31, 2014 and wishes to evidence this assignment by executing this instrument.
