TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "**Termination**"), is dated as of April 27, 2017, and made by FIFTH THIRD BANK ("**Grantee**") to MANSFIELD OIL COMPANY OF GAINESVILLE, INC., a Georgia corporation, MANSFIELD SYSTEMS, INC., a Georgia corporation, C&N ETHANOL MARKETING, LLC, a Minnesota limited liability company, MANSFIELD POWER AND GAS, LLC, a Georgia limited liability company, MANSFIELD ENERGY CORP., a Georgia corporation, and NOBLE MANSFIELD RENEWABLE ENERGY HOLDINGS, LLC, a Delaware limited liability company (collectively, "**Grantor**").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of June 26, 2014, made by Grantor in favor of Grantee (the "**Trademark Security Agreement**"), a security interest was granted by Grantor to Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on July 3, 2014, at Reel 005315 and Frame 0771; and

WHEREAS, Grantee now desires to terminate and release the Trademark Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Release of Security Interest. Grantee hereby terminates the Trademark Security Agreement and terminates, releases and discharges its security interest in the trademarks listed on Exhibit A hereto (the "**Trademarks**") and the other "**Trademark Collateral**" described in the Trademark Security Agreement (collectively, the "**Trademark Collateral**"), and Grantee hereby releases and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademark Collateral.
2. Costs. Grantor shall bear all costs of recording this Termination.
3. Governing Law. This Termination shall be governed by the laws of the State of Georgia.
