UNITED STATES TRADEMARK ASSIGNMENT

WHEREAS, Assignor and Assignee entered into an acquisition agreement dated February 1, 2016, pursuant to which Assignor agreed to assign and transfer certain intellectual property rights to Assignee, including the Mark pursuant to this Assignment; and

WHEREAS, Assignee wishes to acquire, and Assignor wishes to assign, all of Assignor's entire right, title and interest in and to the Mark, together with the goodwill connected with and symbolized by the said Mark;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

Assignor does hereby sell, grant, assign, transfer, convey and deliver to Assignee all of its right, title and interest in and to the Mark, including any and all applications and registrations therefor, and including the goodwill of the business symbolized thereby; and all claims or causes of action Assignor has or may have in connection with the Mark, including, without limitation, rights to sue, bring actions and recover and hold damages, profits and other compensation for any and all past and future infringements and unauthorized uses of the Mark.

Assignor authorizes and requests the United States Patent and Trademark Office to record Assignee as the owner of the entire right, title and interest in and to the Mark, for the sole use


and enjoyment of Assignee. Assignor covenants and agrees that, upon the request of Assignee, Assignor shall execute all papers and furnish such documents, materials and information necessary to perfect the assignment of the Mark to Assignee and otherwise carry out the intent of this Assignment.


