(b) all trademarks and service marks listed in Schedule I attached to this Assignment (hereinafter "MARKS") in all countries throughout the world, together with all goodwill associated with the MARKS, all registrations for the MARKS, and all rights to any and all causes of action and/or remedies related to the MARKS (including the right to sue for past, present and/or future infringement, misappropriation or violation of rights relating to the MARKS);

(c) all domain names, social media sites and websites of the EASY WOOD BUSINESS and the right to use such domain names, social media sites and websites used at or for the EASY WOOD BUSINESS;

(d) all patents and patent applications listed in Schedule 2 attached to this Assignment (hereinafter "PATENTS"), and any and all patents issuing from any and all continuation, divisional, renewal, substitute and/or reissue applications of said PATENTS throughout the world;

(e) all rights in all computer software, both source and object codes, relating to the EASY WOOD BUSINESS;


(f) all UPC (Universal Product Code) barcodes of the EASY WOOD BUSINESS.
