This Certificate of Merger is being filed by the undersigned in the Office of the Secretary of State of the State of Georgia in accordance with the provisions of Section 14-2-1104 and Section 14-2-1105 of the Georgia Business Corporation Code (the "GBCC") in order to merge The Steritech Group, Inc., a Georgia corporation (the "Subsidiary"), with and into Rentokil North America, Inc., a Pennsylvania corporation ("Parent" or the "Surviving Corporation"), which shall be the Surviving Corporation (the "Merger").

FIRST: This Certificate of Merger, and the Merger, shall become effective at 12:01 am. on January 1, 2017 (the "Effective Time").

SECOND: The name and state of incorporation of each of the constituent corporations to the Merger are as follows:

Rentokil North America, Inc.	Pennsylvania
The Steritech Group, Inc.	Georgia

THIRD: The name of the Surviving Corporation in the Merger is Rentokil North America, Inc.

FOURTH: At the Effective Time, the Amended and Restated Articles of Incorporation of Parent shall be the articles of incorporation of the Surviving Corporation.

FIFTH: The executed plan of merger is on file at the principal place of business of the Surviving Corporation, the address of which is 1125 Berkshire Blvd, Ste 150, Wyomissing, PA 19610.

SIXTH: A copy of the plan of merger will be furnished by the Surviving Corporation, on request and without cost, to any shareholder of any corporation that is a party to the Merger.


SEVENTH: Pursuant to Section 14-2-1103(h) of the GBCC, the approval of the shareholders of the Surviving Corporation is not required. Pursuant to 14-2-1104(a) of the GBCC, the approval of the Parent, in its capacity as the sole shareholder of the Subsidiary, is not required.

EIGHTH: A request for publication of a notice of filing this Certificate of Merger, and payment therefore, will be made as required by Section 14-2-1105.1(b) of the GBCC.

NINTH: The merger of the Subsidiary with and into Parent is intended to constitute a tax-free reorganization pursuant to Section 368(a)(1)(A) of the Internal Revenue Code and the Parent intends to continue the business of the Subsidiary after the merger.
