## ASSIGNMENT OF TRADEMARK AND FEDERAL TRADEMARK APPLICATION

THIS ASSIGNMENT OF TRADEMARK AND FEDERAL TRADEMARK APPLICATION is entered into this 28th day of April, 2017, by and between The Foothills Bank, an Arizona corporation (the “*Assignor*”), and Glacier Bancorp, Inc., a Montana corporation (the “*Assignee*”).

### RECITALS:

WHEREAS, Assignor is the owner of the trademark “FOOTHILLS BANK,” an application for which was filed with the United States Patent and Trademark Office (“USPTO”) in Class 36 as App. No. 86/531,980 (“*The Trademark*”), registration of which is subject to the outcome of a concurrent use proceeding pending before the Trademark Trial and Appeal Board and owns all goodwill associated with The Trademark;

WHEREAS, Assignee is party to that certain Plan and Agreement of Merger among Assignee, Glacier Bank (a wholly owned subsidiary of Assignee), TFB Bancorp, Inc. (the parent company of the Assignor), and Assignor (the “*Merger Agreement*”) under which Assignor will merge with and into Glacier Bank (the “*Merger*”);

WHEREAS, as part of the Merger and pursuant to the terms and conditions of the Merger Agreement, at the effective time of the Merger, Assignee will acquire all rights, title and interest in and to The Trademark, including U.S. App. No. 86/531,980, and Assignor desires to assign The Trademark and U.S. App. No. 86/531,980 to Assignee as part of the Merger and pursuant to the terms and conditions of the Merger Agreement.

### AGREEMENT:

WHEREFORE, for good and valuable consideration paid to the Assignor by the Assignee as set forth in the Merger Agreement, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee the worldwide full and exclusive right, title, and interest in and to The Trademark and U.S. App. No. 86/531,980, together with the benefit of any use of The Trademark, any and all goodwill associated with The Trademark, all common law rights related to the Trademark, all rights of renewal and extension, and the rights to recover damages and profits for past infringement.


