RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”), dated as of April 27, 2017, is made by and from DEUTSCHE BANK AG NEW YORK BRANCH, for itself and as Collateral Agent for the Secured Parties (in such capacities, the “**Assignor**”), to and in favor of Endo Global Ventures (for itself and as successor to Auxilium US Holdings, LLC), Auxilium International Holdings, LLC (formerly known as Auxilium International Holdings, Inc.), Actient Pharmaceuticals LLC (for itself and as successor to Actient Holdings LLC), Slate Pharmaceuticals, LLC (formerly known as Slate Pharmaceuticals, Inc.), Actient Therapeutics LLC, 70 Maple Avenue, LLC, and Auxilium Pharmaceuticals, LLC (formerly known as Auxilium Pharmaceuticals, Inc.) (the “**Assignees**”).

W I T N E S S E T H:

WHEREAS, the Assignees and the Assignor are parties to (i) that certain US Pledge and Security Agreement, dated as of February 28, 2014, (ii) that certain Guaranty, dated as of February 28, 2014 and (iii) that certain Confirmatory Grant of Security Interest in United States Trademarks, dated as of January 29, 2015 (the “**Trademark Security Agreement**”);

WHEREAS, pursuant to the Trademark Security Agreement, the Assignees pledged and granted to the Assignor, on behalf of and for the benefit of the Secured Parties, a security interest in all of each of the Assignee’s right, title and interest, wherever located and whether then owned or thereafter acquired in and to (collectively, the “**Trademark Collateral**”):

- (a) its trademarks (including service marks), trade names, trade styles, trade dress, and the registrations and applications for registration thereof, including those listed on Schedule I attached hereto, and the goodwill of the business symbolized by the foregoing; (collectively, the “**Trademarks**”);
- (b) all renewals of the foregoing;
- (c) all rights to sue for past, present and future infringements of the foregoing, including the right to settle suits involving claims and demands for royalties owing;
- (d) all income, royalties, damages, claims and payments then or thereafter due or payable with respect thereto, including, without limitation, damages, claims and payments for past and future infringements thereof); and
- (e) all rights corresponding to any of the foregoing throughout the world.

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on February 4, 2015 at Reel/Frame No. 5453/0246; and

WHEREAS, the Assignees desire that the Assignor terminate, release and discharge fully its security interest the Trademark Collateral.

NOW THEREFORE, in consideration of the premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor agrees as follows:

SECTION 1. Defined Terms. Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Trademark Security Agreement.

SECTION 2. Termination and Release. The Assignor hereby terminates, releases and discharges fully, without representation or warranty, its security interest in and to the Trademark Collateral, including the Trademarks listed on Schedule I attached hereto, and reassigns and transfers to the Assignees all right, title and interest that the Assignor may have in the Trademark Collateral.

SECTION 3. Recordation. The Assignor hereby authorizes the Assignees, or the Assignees' authorized representatives, to record this Release with the United States Patent and Trademark Office.

SECTION 4. Further Assurances. The Assignor hereby agrees to duly execute and deliver to the Assignees any further documents and to do such other acts that the Assignees (or their respective agents or designees) reasonably request, at the Assignees' sole cost and expense, in order to confirm this Release and the Assignees' right, title and interest in the Trademark Collateral.

SECTION 5. Governing Law. THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK.






