RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “*Release*”) is made as of the 12th day of April, 2017 by Escalate Capital Partners SBIC III, LP (together with its successors and assigns, “*Lender*”).

WHEREAS, reference is made to that certain Intellectual Property Security Agreement, dated as of August 11, 2015 (the “*Intellectual Property Security Agreement*”), by and between CML Media Corp., a California corporation (“*Borrower*”), and Lender, which was recorded with the United States Patent and Trademark Office on August 19, 2015 in the trademark assignment records under reel/frame number 5602/0479; all capitalized terms used herein but not otherwise defined herein shall have the meanings assigned thereto in the Intellectual Property Security Agreement; and

WHEREAS, pursuant to the Intellectual Property Security Agreement, Borrower granted Lender a security interest in all of the right, title and interest of Borrower in and to the Intellectual Property identified therein.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby irrevocably and forever releases and terminates its security interest in and to the Intellectual Property arising under the Intellectual Property Security Agreement, including, without limitation, the intellectual property described in Schedules A, B, and C hereto. Further, Lender understands and agrees that this Release may be recorded by or for Borrower with the United States Patent and Trademark Office and any other similar office or agency throughout the world. Lender also agrees to execute any other documents and take any further action reasonably necessary in any jurisdiction that Borrower may reasonably require to effect the intent and purpose of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of California without regard to conflicts of law principles.


