**RELEASE OF TRADEMARK SECURITY AGREEMENT**

**THIS RELEASE OF TRADEMARK SECURITY AGREEMENT** (this “Release”) is made as of May 1, 2017 (the “Effective Date”) by JPMorgan Chase Bank, N.A., in its capacity as collateral agent (together with its successors, the “Collateral Agent”) for the benefit of Circus and Eldorado Joint Venture, LLC, a Nevada limited liability company, and CC-Reno LLC, a Nevada limited liability company (together, the “Grantors”).

**WHEREAS**, pursuant to the terms and conditions of (i) that certain Pledge and Security Agreement, dated July 23, 2015 (as amended, restated, supplemented or otherwise modified from time to time), among the Grantors, the other grantors party thereto and the Collateral Agent (the “Pledge and Security Agreement”), and (ii) the Trademark Security Agreement, dated December 21, 2015, among the Grantors and the Collateral Agent (the “Trademark Security Agreement”), each Grantor pledged, assigned and granted to the Collateral Agent a continuing security interest in all of its right, title and interest in and to certain Trademark Collateral, as defined therein, including, without limitation, the trademark registrations and applications set forth on Schedule A to the Trademark Security Agreement, along with the goodwill associated therewith (collectively, the “Trademarks”);

**WHEREAS**, the Trademark Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on February 16, 2016 at Reel 5732 and Frame 0347;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the Trademark Security Agreement, and hereby terminates, cancels, discharges and releases all of its security interests in and to the Trademark Collateral, including the Trademarks listed under Schedule I attached hereto and the goodwill exclusively symbolized thereby, arising under the Pledge and Security Agreement and the Trademark Security Agreement.


If and to the extent the Collateral Agent has acquired any right, title or interest to any of the Trademark Collateral, it hereby re-assigns and re-transfers such rights, title or interest to the Grantors.

The Collateral Agent shall take all further actions, and provide to the Grantors and their respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors to more fully and effectively effectuate the purposes of this Release, all at the expense of the Grantors.

This Release shall be governed by and construed in accordance with, the laws of the State of New York.

**IN WITNESS WHEREOF**, the Collateral Agent has caused this Release to be executed by its duly authorized representative as of the Effective Date.
