## **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of April 28, 2017 ("Effective Date") by NewStar Financial, Inc. ("NewStar"), as administrative agent for the Lenders and the other Secured Parties under the Trademark Security Agreement (as defined below) (in such capacity, together with its successors and permitted assigns, the "Agent"), in favor of Apple Zebra CFS, LLC (the "Grantor").

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement by and between Grantor and Agent dated October 14, 2016 (the "Trademark Security Agreement"), Grantor granted to Agent a continuing priority security interest in and to all of such Grantor's right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including, without limitation, the trademark registrations and applications set forth on Schedule I attached hereto, in each case, together with the goodwill associated therewith;

**WHEREAS**, Grantor and Agent entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Guaranty and Security Agreement by and between the parties signatory thereto and Agent, dated July 22, 2016 (the "Guaranty and Security Agreement");

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on October 17, 2016, at Reel/Frame 5901/0188; and

**WHEREAS**, Grantor has paid all of its outstanding indebtedness to Agent.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby terminates the Trademark Security Agreement and the Guaranty and Security Agreement, and hereby terminates, cancels and releases any and all security interests it has in the Trademark Collateral.
