

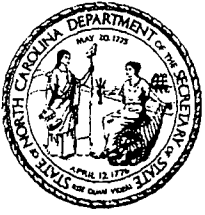

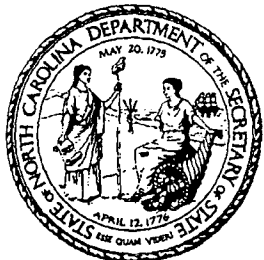

AMENDMENT OF ARTICLES OF ORGANIZATION


