**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "Release"), dated as of April 21, 2017, is made by Healthcare Financial Solutions, LLC, as successor agent to General Electric Capital Corporation in its capacity as Agent (the "Agent"), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

**WHEREAS**, in connection with that certain Credit Agreement dated as of October 3, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), by and among Agilintas USA, Inc., an Illinois corporation (the "**Borrower**"), the other Credit Parties, Healthcare Financial Solutions, LLC, as Agent for the Lenders and the L/C Issuers, the Lenders and L/C Issuers have severally agreed to make extensions of credit to the Borrower;

**WHEREAS**, each Grantor has agreed, pursuant to a Guaranty and Security Agreement of even date in favor of Agent (as amended, restated, supplemented or otherwise modified from time to time, the "**Guaranty and Security Agreement**"), to guarantee the Obligations of the Borrower;

**WHEREAS**, in connection with the Credit Agreement, Guaranty and Security Agreement and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "Security Agreements"), the Borrower and certain of the other Credit Parties (the "Grantors") granted security interests in the intellectual property owned by Grantors, including those listed on Annex I attached hereto (the "Intellectual Property Collateral"); and

**WHEREAS**, the Security Agreements were recorded in the United States Patent and Trademark Office (the "USPTO") on the dates and on the reel and frame numbers set forth on Annex I hereto.

**NOW THEREFORE**, the Agent hereby releases, without representation, recourse or warranty whatsoever, all of its security interest in the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Agent hereby reassigns any and all such right, title and interest (if any) that the Agent may have in the Intellectual Property Collateral to the Grantors.

The Agent agrees, at Grantors' expense, to cooperate with Grantors and to provide Grantors with the information and additional authorization reasonably required or desirable to effect the release of the Agent's security interest in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
