**FOURTH:** The Certificate of Incorporation of the surviving corporation shall be its Certificate of Incorporation. (If amendments are affected please set forth)


**FIFTH:** The authorized stock and par value of the non-Delaware corporation is Ten Thousand Common Stock Shares No Par Value.
