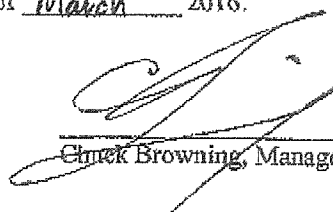

The undersigned, acting pursuant to the Arkansas Small Business Entity Tax Pass Through Act, Ark. Code Ann. §4-32-101 et seq., hereby adopts the following Articles of Organization for such limited liability company:

1. Converting Entity. The name of the Converting Entity is Banded Brands, LLC. The Converting Entity is a Nevada limited liability company, formed December 8, 2010 with the assigned Nevada entity number of E0612252010-5.
2. Converted Entity. The name of the Converted Entity is Banded Brands, LLC.
3. Continued Existence. The Converting Entity is continuing its existence as an Arkansas limited liability company.
4. Jurisdiction. The Converted Entity will be an Arkansas limited liability company.
5. Conversion. Membership interests in the Converting Entity shall be converted into equal membership interests in the Converted Entity.
6. Plan of Conversion. A copy of the Plan of Conversion is attached hereto as Exhibit A ("Plan"). The Plan has been prepared and approved in accordance with Arkansas Code Annotated Section 4-32-1202, Nevada Revised Statutes Annotated 92A.150, and the Converting Entity's Operating Agreement.
7. Approval. The Plan of Conversion has been approved as required by the laws of the Converting Entity's jurisdiction of formation and by its governing documents.
8. Good Standing Certificate. Attached hereto as Exhibit B is a certificate from the state of Nevada that certifies that the Converting Entity is in good standing for purposes of this conversion.
9. Registered Agent. The name of the registered agent is Chuck Browning.
10. Address. The address of the registered agent is 1710 Powell Street, Springdale, Arkansas 72764.
11. Management. The management of the Converted Entity shall be vested in a manager.

PLAN OF CONVERSION
OF
BANDED BRANDS, LLC

This Plan of Conversion (the "Plan") is for the purpose of effecting the conversion of Banded Brands, LLC, a Nevada limited liability company (the "Company" or "Converting Entity"), from a Nevada limited liability company to an Arkansas limited liability company ("Converted Entity") in accordance with and pursuant to the provisions of the Nevada Business Associations Statutes and the Arkansas Small Business Entity Tax Pass Through Act (collectively referred to herein as the "Applicable Law") in substantially the following manner:

1. Conversion. This Plan shall be effective upon the date adopted by the requisite vote or consent of the Member the Company under Applicable Law ("Effective Date"). After the Effective Date, the Converted Entity shall be named Banded Brands, LLC. Pursuant to this Plan, the membership interests in the Converting Entity shall be converted into equal membership interests in the Converted Entity. The Converting Entity is continuing its existence in the organizational form of the Converted Entity. After conversion, the Converted Entity will be an Arkansas limited liability company.

2. General Authority. Following the Effective Date, Chuck Browning, the Manager of the Company, is hereby authorized to take all action necessary or desirable to convert the Company to an Arkansas limited liability company under this Plan and Applicable Law.


3. Articles of Organization. A copy of the Articles of Organization for Banded Brands, LLC, an Arkansas limited liability company are attached hereto as Exhibit A.

FURTHER RESOLVED, that Chuck Browning, as Chief Executive Officer of the Member, (i) be, and hereby is, authorized and empowered to execute and deliver on behalf of the Company the Plan of Conversion and all such other articles, instruments, documents, certificates or agreements necessary to consummate the Conversion, including such changes therein and modifications thereto as he shall upon his sole discretion approve, which approval shall be conclusively evidenced by his execution thereof, (ii) be and hereby is, authorized, directed, and empowered to take any and all action on behalf of the Company as he deems necessary, proper, or advisable to effect and carry out the Conversion, and (iii) be, and hereby is, authorized, directed, and empowered to do and perform all such acts and things and execute and deliver all such certificates and such other instruments, consents, waivers, and other documents on behalf of the Company as he deems necessary or appropriate in order fully to effectuate the purposes of the foregoing resolutions, and all such actions taken by him are hereby ratified and affirmed; and

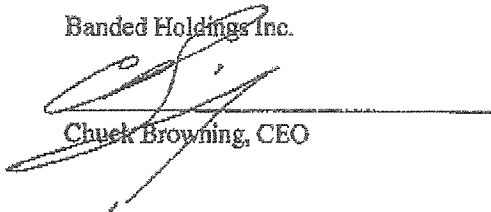

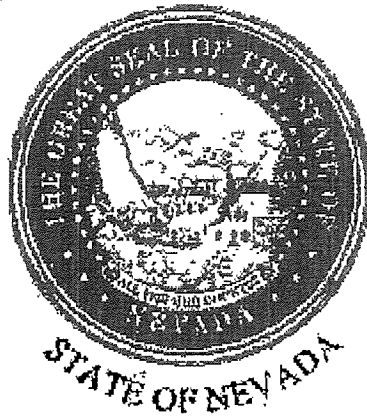
