Trademark VISTM-ADV008 - BANESCO HOLDING MARCAS, S.L. Unipersonal filed an opposition against the NATIVE SELECT mark in the EU. Our response deadline was 2/25/2017 and we filed no reply which means the opposition matter will be dismissed shortly and VMC's NATIVE SELECT mark will not register in the EU.

Trademark VISTM-ADV004 – Screen6 B.V. filed an opposition against the TRUE REACH mark in the EU. Our response deadline was 7/5/2016 and we filed no reply which means the opposition matter was dismissed and VMC's TRUE REACH mark will not register in the EU. Screen6 B.V. was awarded €650. There is no legal basis for them enforce the award of costs, without seeking a court directive which would cost more to obtain than the actual costs themselves, so we do not anticipate any further action from Screen6 B.V.
