## SCHEDULE 2

### TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this “**Assignment**”) is made effective as of 5:00 p.m. Eastern Standard Time on January 23, 2017, by and among Bob Evans Farms, Inc., a Delaware corporation (“**Delaware**”), Bob Evans Farms, LLC, an Ohio limited liability company (“**BEF LLC**”), BEF Foods, Inc., an Ohio corporation (“**BEF Foods**”, and together with Delaware and BEF LLC, “**Assignors**” and all with an address of 8111 Smiths Mill Road, New Albany, Ohio 43054), and Bob Evans Core, LLC, a Delaware limited liability company, with an address of 8111 Smiths Mill Road, New Albany, Ohio 43054 (the “**Assignee**”).

WHEREAS, Assignors have adopted and used and are using in commerce the trademarks set forth in the attached Schedule I (the “**Marks**”); and

WHEREAS, Assignors and Assignee have entered into an Intellectual Property Contribution Agreement dated as of January 23, 2017 (the “**Agreement**”) and pursuant to the Agreement, Assignee wishes to acquire from Assignors, and Assignors wish to transfer to Assignee, said Marks and the goodwill associated with such Marks.

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignors and Assignee agree as follows:

1. Assignors hereby assign and transfer to Assignee, its successors and assigns, all rights, title and interests in and to the Marks, the goodwill of their business symbolized by the Marks, and all rights of action accrued and to accrue under and by virtue thereof, including the right to sue and recover for past, present and future infringement; provided that, with respect to the United States intent-to-use trademark applications set forth on Schedule I, the transfer of such applications accompanies the transfer of Assignors’ business, or portion of the business to which the Mark pertains, and that business is ongoing and existing. Assignors agree to execute all documents and assignments and to perform such other acts as Assignee may reasonably request to secure to it the rights hereby conveyed.
2. Assignors shall duly execute and deliver or cause to be executed and delivered all instruments of sale, conveyance, transfer and assignment, and notices, releases, acquittances and other documents and perform such further acts reasonably requested by Assignee, as may be necessary to convey, transfer, assign and deliver to, and consolidate, vest and record in Assignee, full ownership of the Marks and other rights conveyed herewith.
3. Assignors hereby request the U.S. Commissioner of Patents and Trademarks and all foreign equivalents to record this Assignment, as to the assigned Marks herein referred to.
4. This Assignment is being delivered in connection with and subject to the Agreement and to the extent of any conflict between this Assignment and the Agreement, the Agreement shall control.


