RELEASE OF SECURITY INTEREST

This Release of Security Interest (this "Release") is made as of May 4, 2017, by WESTERN ALLIANCE BANK ("Lender"), in favor of CRYPTZONE NORTH AMERICA INC., a Delaware corporation, formerly known as HiSoftware Inc. and Hiawatha Island Software Company, and successor in interest to Cryptzone US Inc., and CRYPTZONE WORLDWIDE, INC., a Delaware corporation (collectively "Borrowers"), with their principal place of business located at 130 Turner Street, Suite 610, Waltham, MA 02453.

Recitals

WHEREAS, Borrowers granted to Lender a security interest in certain intellectual property, including, without limitation, the copyrights, patents and trademark items listed on Exhibits A, B and C attached hereto, respectively (collectively, the "Intellectual Property"), under an Intellectual Property Security Agreement, dated as of October 29, 2015 (the "Security Agreement"), which was recorded with the US Copyright Office and US Patent and Trademark Office as set forth on Exhibits A, B and C, respectively; and

WHEREAS, Borrowers have no outstanding obligations to Lender under the terms of the Security Agreement and Lender agrees to release its security interest in the Intellectual Property.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby states as follows:

1. Lender hereby (i) terminates the Security Agreement and (ii) releases and discharges any and all security interests that it has pursuant to the Security Agreement in the Intellectual Property and (iii) reconveys to Borrowers, without warranty or recourse, all interest of Lender in the Intellectual Property.
2. Lender agrees, at Borrower's expense, to take all further actions, and provide to Borrowers and their successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Borrowers and their successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.
3. This Release shall be governed by the laws of the State of California and shall become effective only when signed by Lender by its due execution in the space provided below.
