## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**WHEREAS**, Grantor granted a security interest in certain intellectual property assets of Grantor, pursuant to that certain Grant of Trademark Security Interest between the Agent, Grantor and other grantors named therein, recorded with the USPTO on March 28, 2011, at Reel 4507 / Frame 0854;

**WHEREAS**, Grantor granted a security interest in certain intellectual property assets of Grantor, pursuant to that certain Grant of Trademark Security Interest between the Agent, Grantor and other grantors named therein, recorded with the USPTO on April 19, 2013 at Reel 5010 / Frame 0415;

**WHEREAS**, Grantor granted a security interest in certain intellectual property assets of Grantor, pursuant to that certain IP Supplement between the Agent and Grantor, recorded with the USPTO on October 16, 2014 at Reel 5382 / Frame 0697 (collectively herein, the “TRADEMARK SECURITY AGREEMENTS”).

NOW, THEREFORE, for value received, the Agent hereby releases its security interest and all of its right, title, and interest in and to the trademarks and trademark applications as granted under the TRADEMARK SECURITY AGREEMENTS including those set forth herein on Schedule I, along with all of the goodwill associated therewith. The Agent agrees to execute and deliver such further instruments and take or cause to be taken such other or further action as the Grantor may reasonably request in order to perfect, confirm or evidence such release.
